## 2018 – 2019 Corporate Season Pass Application

**The Anthony Lakes Mountain Resort Corporate Season Pass Program is designed to provide local and surrounding businesses the opportunity to offer their employees daily lift tickets to ALMR.**

- With a corporate season pass, employees of your company can ski/ride any day that Anthony Lakes is operating.
- A program administrator must be identified. The Program Administrator (PA) will be responsible for knowing the program requirements and will act as the company's primary contact with Anthony Lakes and provide Anthony Lakes with a list of authorized employees.
- Corporate Pass users (employees) must comply with the *Corporate Season Pass Requirements*, *Skier/Rider Responsibilities*, and *Terms of Consideration* described on the second page of this application.
- The privileges of the ALMR Corporate Season Pass are not refundable or transferable and are not intended for employees' family members or friends (please ask about Family Season Pass rates).
- Improper use of the Corporate Pass program will result in termination of pass use without refund.

\_\_\_\_\_ (PA Initials) **CORPORATE SEASON PASS REQUIREMENTS:** Anthony Lakes Mountain Resort offers Corporate Season Passes as an accommodation to the employees of businesses with frequent skiers/riders. Purchase of a Corporate Season Pass constitutes a release of liability including claims based upon negligence, but it does not apply to claims based upon willful or intentional misconduct. Users of this corporate season pass assume all risks of personal injury, loss or property damage. Reference to "skiers" in this document refers to all people using all types of skis and snowboards.

\_\_\_\_\_ (PA Initials) **SKIER/RIDER RESPONSIBILITIES:** In accordance with ORS 30.985, (a) Skiers who ski in any area not designated for skiing within the permit area assume the inherent risks thereof, (b) Skiers shall be the sole judges of the limits of their skills and their ability to meet and overcome the inherent risks of skiing and shall maintain reasonable control of speed and course, (c) Skiers shall abide by the directions and instructions of the ski area operator, (d) Skiers shall familiarize themselves with posted information on location and degree of difficulty of trails and slopes to the extent reasonably possible before skiing on any slope of trail, (e) Skiers shall not cross the uphill track of any surface lift except at point clearly designated by the ski area operator, (f) Skiers shall not overtake any other skiers except in a manner as to avoid contact and shall grant the right of way to the overtaken skiers, (g) Skiers shall yield to the other skiers when entering a trail or starting downhill, (h) Skiers must wear retention straps or other devices to prevent runaway skis, (i) Skiers shall not board rope tows, j-bars, ski lifts or other similar devices unless they have sufficient ability to use the devices and skiers shall follow any written or verbal instructions that are given regarding the devices, (j) Skiers, when involved in a skiing accident, shall not depart the ski area without leaving their names and addresses, if reasonably possible, (k) A skier who is injured should, if reasonably possible, give notice of the injury to the ski area operator before leaving the ski area, (l) Skiers shall not embark or disembark from a ski lift except at designated areas or by the authority of the ski area operator.

\_\_\_\_\_ (PA Initials) **TERMS OF CONSIDERATION:** Anthony Lakes Mountain Resort reserves the right to close any of its operations if, in its sole opinion, weather conditions are too extreme to safely have skiers using its facilities, or if other difficulties cause or require that any facilities be shut down. Any individual who in the sole opinion of the management of Anthony Lakes Mountain Resort fails to observe the safety rules of the area or attempts to aid any person in fraudulently obtaining a lift ticket will automatically forfeit, without refund, all rights and privileges of a season pass holder in the Anthony Lakes Mountain Resort area.
